### 4. FIRST-AID MEASURES

<b>Eye Contact</b>	Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. If eye irritation persists: Get medical advice/attention.
<b>Skin Contact</b>	Flush skin with plenty of water for at least 15 minutes, remove any contaminated clothing. Seek immediate medical attention.
<b>Inhalation</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. If breathing is irregular or stopped, administer artificial respiration. Call a poison center or doctor/physician if you feel unwell.
<b>Ingestion</b>	Do not induce vomiting. Rinse mouth. Immediately give 3-4 glasses of milk, egg whites or gelatin solution (if none, give water for dilution). ### 5. FIRE-FIGHTING MEASURES

**Suitable Extinguishing Media**

### **Specific Hazards Arising from the Chemical**

As with most organic solids, fire is possible at elevated temperatures or by contact with an ignition source. Thermal decomposition can lead to release of irritating and toxic gases and vapors.
